PRIVATE POSTSECONDARY EDUCATION INFORMATION BULLETIN Number 31(Jan. 1987) California Degree-Granting Authority and recognition

Regulation by the Superintendent

The California Legislature has enacted statutes (codified as Chapter 3, part 59, Division 10 of the California Education Code) providing regulation of private postsecondary educational institutions by the Superintendent of public Instruction. The Superintendent's staff in the Private Postsecondary Education Division of the Department of Education carry out the mandated functions. The Council for Private Postsecondary Educational Institutions is a statutory advisory body to the superintendent for matters affecting the sector. The Superintendent provides further detail to the statutes by adopting official regulations (codified as Division 21, Title 5 of the California Administrative Code), formal procedure, and policies.

Degree-Granting Authority

The law requires any person, firm, association, partnership, or corporation which offers academic or honorary degrees, educational services, or instruction leading toward degrees-within or from the State of California-to be subject to the regulatory provisions. The law provides for exemption and for four categories of legality to operate degree-granting institutions.

California Education Code Categories

- * Section 94303(b) the degree is limited to evidence of completion of education restricted solely to the principles of a church or denomination. There exists no recognition by any agent or agency of the State of California for such exempted status.
- * Section 94310.1(a) the degree is conferred by an institution which is accredited by a national accreditation agency recognized by the U.S. Department of Education, or accredited by the Western Association of Schools and Colleges, or accredited by the Committee of Bar Examiners for the State of California.
- * Section 94310.1(b) the degree is conferred by an out-of-state regionally accredited institution operating program in California.
- * Section 94310.2 the degree is conferred by an institution having full institutional approval by the Superintendent of Public Instruction for all being consistent with accredited institutions in terms of curricula quality and verifiable evidence of graduates' academic achievement.
- * Section 94310.3 the degree is conferred by an institution which has been authorized to operate by virtue of complying with formal standards adopted by the superintendent.
- * Section 94310.4 the degree conferred is by a school of theology offering degrees in theology or ministry and has been authorized to operate by the superintendent having determined that the "full disclosure" filing is truthful and accurate.
- [] F. CEC 94303 Exemption from possessing any approval or authorization for religious education, avocational or hobby-type education, pre-school through 12th grade education, or education by a public, tax-supported entity.
- [] 9. The institution you named is "approved for veterans" by this state approving agency for the veterans Administration to train veterans and eligible persons. School personnel can advice you whether the current status of approval will allow enrollment at this time for reimbursement of educational benefits by the federal VA. - [] 12. Regarding the transfer of credit or recognition of course work or degrees- realize that there are no laws requiring a person or entity to recognize educational accomplishments. You must personally check with those persons and entities who most likely will evaluate your educational history to determine if they will recognize or accept in transfer the credits or course work completed. Credit is transferred or recognized on a very personal and individual basis. National accreditation historically has been to assure credit transfer from one accredited institution to another; but even credited institutions are very selective in recognizing credits taken at other institutions.
- []13. The agency, organization, or association you named as an accreditation agency is not recognized by the United States Department of Education as an accreditation agency, therefore, California law does not consider any status accorded to an institution by such reorganized agency, organization, or association as "accreditation" as defined by California Education Code Section 94302 (q).
- [] 14. Private Insitutions are recognized by California law as being "accredited," " authorized to operate," "approved," or "exempted." Accreditation refers to a status accorded an institution by an agency which has been recognized by the United States Department of Education as an accreditation agency, and California law recognizes "accreditation" by the California State Committee of Bar Examiners for law schools. Authorization refers to the permission the Superintendent grant an educational institution to operate on the basis of an underlying approval, accreditation, or licenser. Approval refers to the status granted an institution on the basis of its meeting at least minimum standards established by the Superintendent through intensive and continuing review and evaluation. Exemption means that an institution need not comply to certain provisions of the Education Code because of the nature of the education offered; refer to Education code section 94303.

> Accredited means that an institution has been recognized or approved as meeting standards established by an accrediting agency recognized by the United States Department of Education, or the Committee of Bar Examiners for the State of California. The council does not accredit institutions.

> This agency does not rank, rate, or recommend schools. We can only respond in terms of its status under the law.
